ONLINE PRIVACY POLICY AGREEMENT

Use of Information Collected

Innovative Transformations does not now, nor will it in the future, sell, rent or lease any of its customer lists and/or names to any third parties.

Innovative Transformations may collect and may make use of personal information to assist in the operation of our website and to ensure delivery of the services you need and request.
